**COSTA RICA**

In special circumstances the Ministry of Labour and Social Security may authorise the employment of more foreigners when it is difficult or impossible to replace them with nationals, but employers remain obliged to train Salvadorian personnel under the supervision and control of the mentioned Ministry within a period of not more than five years. The amount of wages of Salvadorians can not be less than eighty five per cent of the total wages paid. This percentage may be changed with the authorisation of the above mentioned Ministry <sup>790</sup> .
