## **Edward Bowles**



Mr Bowles is the Regional Head of Corporate and Public Affairs, Europe at Standard Chartered Bank, where he has held a number of roles since 2007. He is also a member of a number of European financial services' industry association committees, covering international regulatory issues and trade negotiations. Prior to this, he was a UK civil servant at the Ministry of Justice, where he served as Private Secretary to the Permanent Secretary and to two Ministers, and as Head of Human Rights Policy.
