

EXECUTIVE SUMMARY

ORIGINAL COMPLAINT

Product Concerned: Urea Ammonium Nitrate Solutions (UAN) Producer / exporters concerned: Russia, Trinidad & Tobago and USA

Applicant: Fertilizers Europe on behalf of 55% of the EU Urea Ammonium Nitrate solutions industry production using calendar year 2017 as the base reference.

This original complaint is based on high rates of dumping; real material injury especially evident from losses suffered; the great likelihood that injurious dumping will continue due to new capacity developments changing trade trends and in the case of Russia the artificial pricing of natural gas to the Russian industry.

Hereunder our the key features of the complaint.

- 1. <u>Regular high rates of dumping</u>: Over the calendar year, the four exporter countries were found to be dumping into the EU at the following rates:
 - a. Russia: 45% or Euro 60/mt using standard methodology;
 - b. **Russia:** 50% or Euro 68/mt considering a profit of 10% and 83% or Euro 112/mt considering a profit of 29% using "adjustment methodology" under Article 2,3 and Article 2,5:
 - c.**Trinidad:** 46% or Euro 65/mt considering a profit of 10% and 78% or Euro 111/mt considering a profit of 29% using "actual constructed value";
 - d.. USA: 43% or Euro 54/mt using "standard methodology";
- 2. <u>there is real deep seated injurious dumping arising from the domestic scene or trading nature of the exporter/producers: -</u>
 - a. **For Trinidad**, the absence of home market and the high capital / operating costs of the single major-mega plant;
 - b. **For Russia** a limited home market in Russia and "structural injurious dumping" arising from the persistent prevailence artificially low domestic gas costs and the Russia's gas dual pricing to Europe;
 - c. **For USA**, very major capacity expansions in the USA which are resulting in surplus product being used to conduct dumping campaigns.


4. Real material injury whereby Exporter /producers' record increased import surges and increased market shares %

The surge of imports is especially notable from the USA which has become the No 1 importer into the EU with a 12% market share by year 2017. Russian market share too has grown to 10%; Trinidad records a stable like 7 to 9%.

- 5. The likelihood of further material injury as all 4 exporter /producers increasingly direct their export capabilities to the EU:
 - 1. With the USA exploiting its local massive shale gas reserves to increase USA UAN capacity from 12.5 KT in year 2013 to 14.6 KT by year 2017, the traditional import flows from Russia and Trinidad into the USA are reducing or will be reduced.
 - 2. The obvious alternative market is the open and attractive EU market the second largest in the world. The USA is the first largest in the world but the USA local capacity can now meet all its local consumption needs.

6. Structural gas distortions in Russia: Furthermore, the prevailance of distorted artificially low state fixed gas prices in Russia explains Russia's structural propensity to dump. This is especially true in the case of Russia which pursues a deliberate gas dual pricing policy whereby gas is sold on a artificially low state fixed basis in Russia to local UAN industry (US\$2.5 MMBTU approx. in year 2017) while selling at very high export gas prices to the EU (over US\$7.00MMBTU).

Thus the EU nitrogen fertilizer industry is injured in several ways. First, by the dumping of UAN fertilizer. Second, by Russia / Gazprom's sale of high oligopolistic gas prices to Europe under a Russian government run export pipeline monopoly. Thirdly, by Gazprom's sale of non market based gas contracts to Belarus on an intergovernmental foreign policy basis.

Faced with increasing EU raw material gas prices and still static or falling UAN prices, the current situation remains especially injurious for the EU industry which therefore requests expeditious and immediate corrective action. Moreover, with regard to the unfair structural distortions on natural gas pricing in Russia promoting dumping, the Complainant on behalf of the thereby injured Union industry requests the lesser duty rule be removed with regard to Russia. This is consistent with the amendment Article 7(2a.) made to the Basic Anti dumping regulation in June 2018.
