Executive Summary

of the

Expiry review request under Article 11 of Regulation 2016/1036 concerning certain prepared or preserved sweetcorn in kernels originating in Thailand

1. Product concerned

The product subject to this review request is preserved sweet corn (in kernels), regardless of whether or not the covering liquid contains vinegar or acetic acid, originating in Thailand:

- Sweetcorn (*Zea mays var. saccharata*) in kernels, prepared or preserved by vinegar or acetic acid, not frozen, currently falling within CN code ex 2001 90 30 (TARIC code 2001 90 30 10)
- Sweetcorn (Zea mays var. saccharata) in kernels prepared or preserved otherwise than by vinegar or acetic acid, not frozen, other than products of heading 2006, currently falling within CN code ex 2005 80 00 (TARIC code 2005 80 00 10).

This product is intended for human consumption. It is usually, but not exclusively, presented in a canned format.

A distinction is to be made between this product and 'baby corn' or 'young corn' (small corncobs often used in salads or exotic dishes), which does not fall within the scope of the request.

2. Standing

This expiry review request is submitted by the European sweet corn processors' association AETMD (Association européenne des transformateurs de maïs doux) on behalf of EU producers of the product concerned representing 60% of EU production (« the Applicants »).

3. Summary of the request

Following an ER investigation (R552) in 2012-2013, the AD measures imposed in 2007 on prepared or preserved sweet corn in kernels from Thailand were extended for a period of 5 years.

AETMD has submitted *prima facie* evidence that imports of the product concerned continued to be dumped in the recent period and that injury to the EU sweet corn industry would recur should the antidumping measures be allowed to lapse.

Therefore, AETMD, on behalf of Union producers of the product concerned, requests that the European Commission initiate an expiry review ("ER") pursuant to Article 11 of the Basic Regulation¹ of the anti-dumping ("AD") measures currently in force with a view to the extension of these measures for a five-year period.

The AD measures have allowed the EU industry to face Thai unfair competition and the trend of steady decline in injury indicators observed during the original investigation stopped.

However, evidence supplied by AETMD demonstrates that there is a strong likelihood of continuation & aggravation of dumping should measures expire. Indeed dumping continued while the measures were in place. Should measures be repealed, the relatively higher price in the EU will attract significant Thai volumes. Thailand has significant spare capacity available. Morever Thai total exports volume continued to grow steadily year on year and are now approximately 10 times Thai exports volume to the Union. Finally, the Union market is attractive compared to other Thai export markets so the risk of trade diversion (at prices lower than current prices to the EU) is high.

Thus the expiry of the AD measures would quickly result in a sharp increase of dumped imports from Thailand into the EU leading to price reduction on the EU market. Prices would start spiralling down again and the Union industry would have to give up profitability to try and maintain its market share.

As a conclusion, the continuation of the AD measures is essential to the survival of the EU industry as without measures high import volumes of heavily dumped imports of the product concerned from Thailand would cause material injury to the EU industry.
