 - Article 147 of the Act on the Rational Use etc. of Energy imposes an obligation on manufacturers of "Energy-Consuming Equipment" (designated under Article 18 of the Ministerial Order of the Act on Rationalizing Energy Use, including rice cookers and cookware using gas energy) to display the energy consumption efficiency of the product.

 - Permission from the MIC Minister is required when microwave heaters or IH cooking heaters which fall under the category of Equipment Utilizing High Frequency Currents, as defined under the Radio Act, are installed, unless the manufacturer or importer has confirmed the conformity of the heaters with the Radio Act and has submitted a report of such confirmation to the MIC Minister.
