

## List of screening mechanisms notified by Member States

**Last update: 14 July 2021**

Pursuant to Article 3.8 of Regulation (EU) 2019/452 of 19 March 2019 establishing a framework for the screening of foreign direct investments into the Union, the Commission shall make publicly available a list of Member States' screening mechanisms and it shall keep the list up to date.

The changes extend the application of a 10% trigger threshold for acquisitions by non EU-foreigners and an associated notification requirement to health-related sectors and adjusts some procedural rules to close identified shortcomings in the operation of the mechanism.
