# Executive Summary of the Request for a New Exporter Review of Anti-dumping Measures on Imports of Trichloroisocyanuric Acid (TCCA) Originating in the People's Republic of China

### 1. Applicant

The applicant for the new exporter review is Hebei Xingfei Chemical Co., Ltd (Hereinafter refer to as "the applicant"). The applicant's address is The Second Industrial Park of Dacaozhuang Management Area, Xingtai City, Hebei Province, China.

### 2. The product concerned

The product concerned is trichloroisocyanuric acid and preparations thereof, also referred to as 'symclosene' under the international non-proprietary name (INN), currently falling within CN codes ex 2933 69 80 and ex 3808 94 20 (TARIC codes 2933 69 80 70, 3808 94 20 20).

With cyanuric acid, caustic soda liquid and chlorine as the main raw material, trichloroisocyanuric acid (TCCA) is usually manufactured through batching, filtration, chlorination, slurry centrifugation, drying, granulation, mother liquor dechlorination, neutralization, multi-effect evaporation and other processes.

TCCA is a chemical product used as a broad-spectrum organic chlorine disinfectant and bleacher, in particular for disinfecting water in swimming pools and spas. Other uses include disinfection of kitchen and bathroom, farm, hotel, hospital, and other public places.

## 3. Summary of the case

#### A. Measures in force

Following an anti-dumping investigation (the original investigation), by means of Regulation (EC) No 1631/2005<sup>1</sup>, the Council imposed a definitive anti-dumping duty

on imports of TCCA originating in the People's Republic of China and the United States of America.

The anti-dumping measures currently in force on imports of TCCA of Chinese origin are measures imposed by Council Implementing Regulation (EU) 2017/2230<sup>2</sup>.

The anti-dumping duty currently applicable to the product produced by the applicant is 42,6 %.

## **B.** Summary of the request

The applicant requests for a new exporter review pursuant to Article 11(4) of the Basic Regulation. The applicant submits to the Commission that:

- a) it is not related to any of the exporters or producers in China which are subject to anti-dumping measures applicable to TCCA;
- b) it did not export TCCA to the Union during the period of investigation, i.e., from 1 April 2003 to 31 March 2004;
- c) it has actually exported to the Union the products concerned after the period of investigation.
